The City of St. Catharines owns and operates a Class II stand-alone residential water distribution system. The City receives its drinking water from the Regional Municipality of Niagara's Decew Water Treatment Plant. The source water is surface water from Lake Erie via an intake from the Welland Ship Canal. The distribution system consists of approximately 593 kilometres of watermain, over 3,500 hydrants and approximately 5,500 valves.

In 2022, approximately \$8,287,000 was budgeted for watermain capital projects. The total length of watermain sections corresponding to the budgeted amount was approximately 5.25 km of watermain.
