Dear Resident:

As you may be aware, construction has begun for the Burleigh Hill/ Glendale Avenue/ Warkdale Drive CSO Control/ Road Reconstruction/ Bypass Sanitary Sewer – Phase 1 project. As part of this project, a sanitary bypass sewer will be installed on Warkdale Drive. During this installation a rolling road closure was proposed for Warkdale Drive and a temporary access road between Rockdale Avenue and Burleigh Hill was proposed to allow residents and emergency vehicles to flow between Burleigh Hill Drive and the Warkdale Drive neighbourhood during the closure.

The Contractor, Nexterra Substructures Inc., has proposed an alternative construction methodology which will allow Warkdale Drive to remain open to one lane of traffic at all times. This method will provide cost savings to the City, allow for residents and emergency vehicles to access Burleigh Hill Drive and the Warkdale Drive neighbourhood at all times.

The City is aware that two (2) trees have already been removed from the location of the proposed temporary access road and tree pruning has taken place on Warkdale Drive. The Contractor will be using the former proposed access road area to install their temporary site trailer and as a laydown area for their equipment and supplies. Please be assured that this area will be restored to pre-construction conditions including the planting of new trees once construction has been completed.
