SUBJECT: Customer Initiated Expansion – 57 Carlisle St, St. Catharines, WO 636209

Dear Customer:

We have a service request for a new high rise building at 57 Carlisle St in St. Catharines. *Please refer to the key map attached to the back of this letter.* This project requires Alectra Utilities to **upgrade distribution assets in the immediate area** to accommodate the electricity service required by this new development.

Alectra Utilities will be performing the following construction work:

- **Distribution poles will be upgraded from 45FT to 60FT to accommodate on St. Paul St West between 70 St. Paul St W and 56 St. Paul St W.**
- **Installing new concrete encased primary ducts via open cut from 60 James St (SE corner of King and James) and 44 James St.**
- **Installing new concrete encased primary ducts via open trench in front of 28 James St at intersection of James St and Summer St**
- **Installing new HDPE ducts via directional bore 3 Garden Park.**
- **Installing new primary underground cables into existing and new ducts along St. Paul St W, James St, William St, King St, James St and Garden Park.**

Alectra Utilities has received the necessary approvals and permits from the **City of St. Catharines** to proceed with this work.

Alectra contractor's Black & McDonald will be primarily working on this project. This project will require **major excavation in some areas as along with minor excavation in others** beside the Municipal Road Allowance to install the **new primary hydro ducts along James St**. Where excavation is necessary, Alectra will undertake every effort to restore the grounds to their original condition. Every effort will be made to maintain both vehicular and pedestrian traffic flow in both direction during construction work.

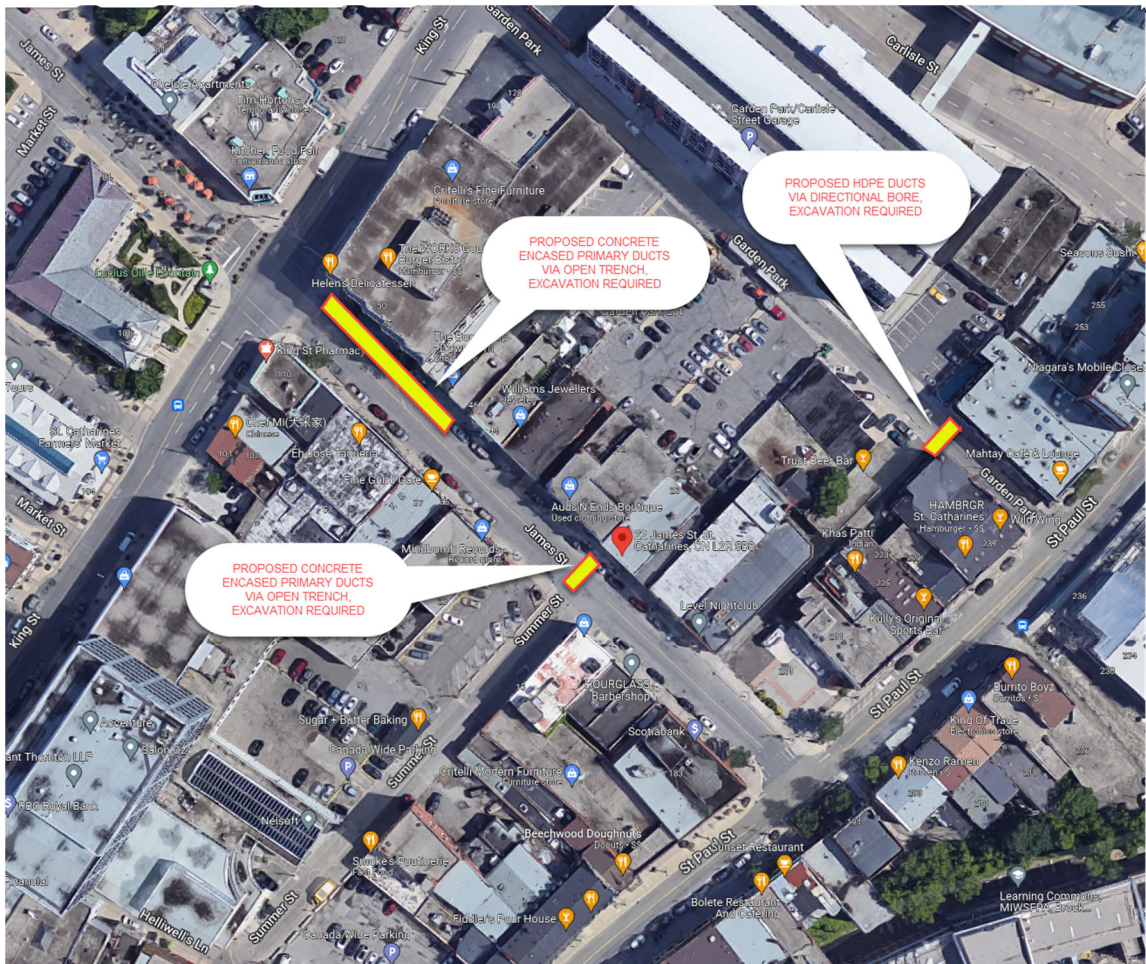
Additionally, construction vehicles and equipment will be apparent, and while we apologize for any inconvenience noise, dust, and crew presence may cause, we want to reassure the community that Alectra and our contractors adhere to best construction practices ensuring a safe work zone. Majority of construction will occur during the weekday typically between the hours of **8 am and 4 pm**.

Scheduled power interruptions may be required to safely complete our work and every attempt will be made to notify you in advance. **If your power will be affected, you will receive notifications by phone or notice on your front door. Please ensure that your primary contact phone number attached to your Alectra Utilities account is current.**

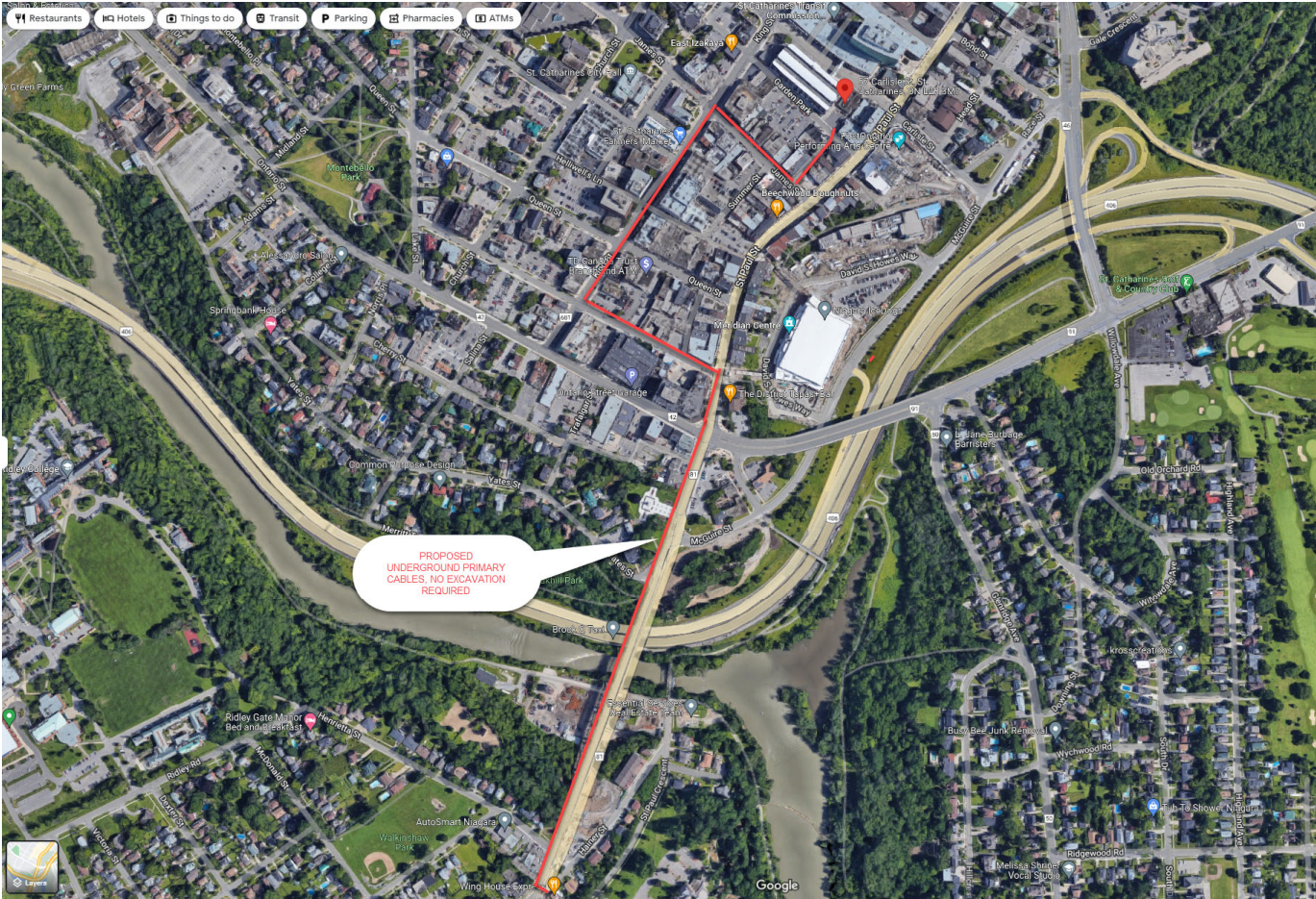
