

Application for Zoning By-law Amendment

Notice of Online Open House

The Planning and Building Services Department is hosting an Online Open House to provide information and receive public input regarding an Application for a Zoning By-law Amendment. The Application is to rezone the lands known municipally as 47 St. Paul Street West.

The Applicant proposes to rezone the lands from Medium Density Mixed Use (M1) to Medium/High Density Mixed Use with Special Provision 171 (M2-171). The Applicant is requesting to rezone the lands to facilitate а proposed five-storey use mixed building containing sixteen (16)apartment dwelling units and one (1) commercial unit. The proposal includes eleven (11) parking spaces.



The proposed Zoning By-law

Amendment will also include a Special Provision to address the zoning deficiencies regarding density, setbacks, landscape buffers, parking, and encroachments.

The City is seeking your comments on this Application before staff recommendation is finalized and a decision is made by Council at a later date.
